The Maryland Department of Transportation Maryland Aviation Administration (MDOT MAA) is issuing Request for Proposals (RFP) MDOT MAA-RFP-22-001 for the Non-Exclusive Right to Redevelop, Renovate, Lease & Manage the Retail, Restaurant & Commercial Services at Baltimore/Washington International Thurgood Marshall (BWI Marshall) Airport.
