TERMINAL CROSSWALKS AT BWI – PHASE 2 Upper and Lower Level Roadway Crosswalk Repairs

Upper Level Terminal Roadway

In support of the Terminal Crosswalks at BWI – Phase 2, the Upper Level Terminal Roadway is scheduled to be impacted nightly starting Sunday, May 21, 2023, beginning at approximately 8:00 p.m. lasting until approximately 4:00 a.m. Work is scheduled to be completed on Friday, June 23, 2023. The total duration of the work is approximately 25 nights with work occurring Sunday evenings through Friday mornings.

During this time, portions of the Upper Level Terminal Roadway will be impacted and closed to pedestrian and vehicle access. Maintenance of traffic will be in place (signs, traffic barrels, and barricades). The following specific areas are anticipated to be impacted during this work:

- Crosswalk access to Terminal doors from Arrivals drop off curb
- Public outer roadway lane closures
- Commercial vehicle roadway lane closures

Lower Level Terminal Roadway

The Lower Level Terminal Roadway is scheduled to be impacted nightly starting Sunday, June 25, 2023, beginning at approximately 11:59 p.m. lasting until approximately 8:00 a.m. Work is scheduled to be completed on Friday, August 4, 2023. The total duration of the work is approximately 25 nights with work occurring Sunday evenings through Friday mornings.

During this time, a portion of the Lower Level Terminal Roadway will be impacted and closed to pedestrian and vehicle access. Maintenance of traffic will be in place (signs, traffic barrels, and barricades). The following specific areas are anticipated to be impacted during this work:

- Crosswalk access to Terminal doors from Departures pick up curb
- Public outer roadway lane closures
- Commercial vehicle roadway lane closures

Employee Terminal Parking Lot

The Employee Terminal Parking Lot is scheduled to be impacted starting Thursday, August 3, 2023, beginning at approximately 7:00 a.m. lasting until approximately 3:00 p.m. daily. Work is scheduled to be completed on Wednesday, August 9, 2023. The total duration of the work is approximately five (5) days.

During this time, a portion of the Employee Terminal Parking Lot crosswalks will be impacted and closed to pedestrian access with signs, traffic barrels, and barricades. Vehicle access will be maintained at all times during the work.

Work is being coordinated with affected tenants and Maryland Aviation Administration offices.

All tenants in the affected areas should take precautionary measures for the work on each of the dates listed. During the work hours, access to the affected crosswalks will be prohibited to perform the work safely.
