BIENNIAL BRIDGE INSPECTION

Between Wednesday, May 29, 2024 and Friday, June 27, 2024, CST Engineering, Inc. (CST) and The Wilson T. Ballard Company (WTB) will be performing required routine inspections for assessment of the condition of 21 bridges adjacent to the Terminal and parking garage.

Inspections by CST will take place on the bridges at the following locations:

- Upper Level Roadway Bridge in front of Concourses B and D
- Lower Level Roadway in front of Concourses B and D
- Hourly Garage Concourse C Pedestrian Tunnel
- Hourly Garage entry and exit ramps
- Skywalks A, B, and D

Inspections by WTB will take place on the bridges at the following locations:

- Upper Level Roadway Bridge in front of Concourses A and E
- Lower Level Roadway in front of Concourses A and E
- Upper Level Roadway Ramp A
- Airport Exit Road Bridge
- Employee Parking Lot Exit Road
- Hourly Garage entry and exit ramps
- Terminal Road north of I-195
- Entrance/Exit Plaza over Daily Parking Garage
- Second Level entrance/exit ramps to Consolidated Rental Car Facility

Inspections utilizing the Lower and Upper Level Roadways will require a one lane closure for a 200-foot interval at a time, with one lane of traffic maintained at all times through the use of cones/flagmen or a truck mounted attenuator.

Lower Level Roadway closures will only occur between 11:00 p.m. and 7:00 a.m.

Upper Level Roadway closures will only occur between 10:00 p.m. and 6:00 a.m.

Only one ramp will be closed at a time at the Hourly Garage.

Traffic disruptions will be kept to a minimum.

A manlift will be utilized for some of the under-bridge inspections and will be stored on-site when not in use. A bucket truck and ladders will be utilized for the remaining under-bridge inspections and will be stored off-site when not in use. An amphibious tracker provided by Harcon Corporation will be used for inspection of the Daily Garage Entrance Ramp bridge on June 24, 2024.

Maryland Aviation Administration (MAA) Airport Operations (410-859-7018) will be notified each day and night prior to closing lanes/ramps and upon re-opening lanes/ramps.
